Minutes of the Annual Parish Council Meeting held in Carbrooke Village Hall on 10 May 2022

Present: Cllrs J Tinson (Chair), J Borrett, M Mawby, P Sampher, G Redfern, M Wormall. In attendance: N Hartley (Parish Clerk). Two members of the public.

Public Participation

A member of the public noted the Council's Budget for 2022/23 and the level of expenditure at Blenheim Grange. He noted item 11 on the meeting's agenda regarding the apportionment of the Council's reserves and requested that the Council write to each village organisation inviting grant applications from them. He noted there is no representative to Carbrooke PCC. He asked if the Council would consider a wider distribution of grants in its Budget for 2023/24 and requested a cap of 20% on a grant to any one organisation.

In response, the Council noted that the village organisations are aware of its Grants scheme and that grants are awaited from the Millennium Green Trust, Heritage Group and PCC. The Council will consider the other matters at its June meeting.

It was **RESOLVED** to elect Graham Redfern as Vice Chair.

3 Apologies for Absence

Apologies were received from Cllr Long, who was working and Cllr Crane (Breckland Council).

4 Report from Breckland Councillor

Cllr Crane (Breckland Council) submitted the following report.

The Breckland mobile food store is launching in May. This is part of the 'Inspiring Communities' programme. Informed by data, the store will be stopping in Carbrooke at The Carbrooke Community Hub. This has been funded by Breckland Council and Norfolk Community Foundation and will be run by Kickstart. The food store will provide a way to shop for healthy food and staples at reduced prices. There will be staff on the bus to help support residents and signpost them to help with isoation, mental health, debt management etc.

Breckland council and consultancy firm Daniel Connal partnership have been awarded The Norfolk Constructing Excellence Award for Sustainability of the new temporary accommodation unit at Elm House, Thetford.

700 trees have been planted throughout the district to celebrate the Queen's Platinum Jubilee.

Refurbishment plans have been announced for the Queen Mother's garden in Dereham.

As part of the Future Breckland project, plans have been drafted for both Watton and Swaffham. Thriving people and places is a project to revitalise Breckland's 5 market towns.

The grant window is now open for match funding up to £5,000. Any project must align with Breckland Councils Inspiring Communities outcomes which are:

- Lead the recovery from Covid19
- Address vulnerability and work with the most disadvantaged members of our community to improve life outcomes.
- To enhance the health and wellbeing of Breckland's residents providing excellent leisure facilities and activities.

The Council considered earmarking additional funds toward repairing the potholes in the Village Hall car park and reshingling the whole of the car park; two solar lights in the Village Hall car park; a new solar light by the power substation at Blenheim Grange; resurfacing the path into the play area at Blenheim Grange.

14 Resurfacing the Path into the Blenheim Grange Play Area

It was **RESOLVED** to resurface the path into the play area as the condition of the path had been highlighted by the inspector in a previous play area report.

15 Request for a light on the path near the power substation

It was **RESOLVED** to carry this forward to a meeting later in the year when the Council will be able to assess its available funds.

16 Approve and complete the Annual Return

It was **RESOLVED** to approve and sign the Annual Return.

It was **RESOLVED** to appoint Cllr Sampher as the Council's Internal Control Officer.

26 Proposal for a Parish Newsletter

Cllr Borrett proposed a parish newsletter funded by advertising revenue. It was **RESOLVED** to conduct a survey to assess the interest in a newsletter.

27 Update on the Community Hub

Cllr Sampher said he had been approached by Buckingham Lodge asking if the Hub could be used as a centre in case of emergencies. It was **RESOLVED** that the Parish Council cannot commit to this.

Cllr Sampher requested a new Parish Council member on the Hub Committee to replace Cllr Long, who has stepped down due to her work commitments. It was **RESOLVED** to appoint Cllr Mawby.

Cllr Sampher noted there will be a Summer Fete on 28 August. He noted the Hub is still waiting for the new bank account to be opened. He thanked Pam Arrowsmith for all her work and said she has been a big asset to the building.

28 Proposal regarding traffic speeds at Norwich Road near the mini roundabout off Blenheim Grange

Cllr Mawby requested traffic calming measures at the mini roundabout at Norwich Road/Lancaster Avenue. It was **RESOLVED** to write to Norfolk County Council.

29 Update on the road adoptions at Blenheim Grange

The consortium had advised the Council that the road adoptions are progressing, but progress is slow. An inspection date for the completion of the street lighting is awaited. The Section37 Adoption plan has been sent to Norfolk County Council and requires some amendments.

30 Stirling Road Fence

The Council had received a request from a resident regarding broken knee rail fencing near their property. It was **RESOLVED** to remove the fencing and posts.
